1. ISINGENISO

ISigaba 32 soMthethosisekelo waseNingizimu Afrika, uNo. 108 we-1990 ("uMthethosisekelo) sinikeza wonke umuntu ilungelo lokuthola ulwazi. UMthetho uNo. 2 wezi-2000 Wokuthuthukisa Ukutholakala Kolwazi ("uMthetho") waziswa ngamhla zi-3 kuNhlojana 2002 ukunikeza amandla leli lungelo ngokugqugquzela isiko lokungafihli lutho kanye nokuzibophezela ezinhlakeni zikahulumeni nezizimele. Ukuze yethule ukuhlaziywa okuyikho nokuzwakalayo kwesimo sayo, iSasria Soc Limited (ebizwa lapha ngokuthi "Sasria") ihlala njalo izama ukuqinisekisa ukuthi ukubika kwayo nokwazisa kwayo bonke ababambe iqhaza kuyona kuyikho, kucacile futhi kuyasebenza.

Leli bhukwana lenziwe ngokulandela iziphakamiso zeSigaba 14 soMthetho esikwenza kube semqoka ukuthi onke amabhizinisi aphethwe uhulumeni enze ibhukwana eliyokuba nomkhombandlela wokuthi umphakathi ungaluthola kanjani noma yiluphi ulwazi oluqokethwe ibhizinisi eliphethwe uhulumeni.
