## **TEMPORARY COVER DURING THE GENERAL ELECTIONS IN MAY 2014**

As in the past, it will be permissible to issue Sasria cover for a short period during the General Elections.

The following Terms and Conditions will apply:

1. The 'Election Coupon' will be issued where an Insured does **not have existing** Sasria covers.
2. The Coupon will relate only to the actual Polling Stations, facilities used by voters and candidates for the purposes of voting during the election period and Storage of Ballot Papers.
3. Existing Sasria covers will cover all Sasria -related occurrences during the entire election process.
4. The Insured may select a maximum of 14 days cover period incorporating the actual date of the Elections.
5. Cover will be restricted to Material Damage.
6. The rate for the cover is 0.0144%, subject to a minimum of R150 and per coupon (minimum premium not to be prorated).
7. Existing underlying policies covering the relevant premises may be used irrespective of the business description in the under-lying policy.
8. The sum insured reflected on the coupon must be adequate and may reflect only the actual building and facilities to be used by the electorate and candidates.
9. The Sasria Coupon must be clearly marked '**Election Coupon**' and must fully describe the buildings, facilities to be used to distinguish the election Coupon from the conventional coupon. The Election Coupon is available for order.

12. Should a claim be made against the Election Coupon, the One Insured limit of the relevant insured will be reduced by the amount of the claim.
